**Conflict of Interest Disclosure**

If the individual has an interest in those entities, a CONFLICT OF INTEREST could exist. If a conflict exists, the reviewer must immediately disclose this conflict to First 5 Fresno County and refrain from participating in any portion of the review process involving the identified entity or entities.

A conflict of interest exists if a person, his/her family or his/her employer stands to benefit personally, professionally, or financially from the outcomes of a decision. Any such conflict may detract from a fair and impartial review process. Examples of a conflict of interest include, but are not limited to, the following relationships between a reviewer and an applicant agency:

- a) Ownership or financial interest;
- b) Director, trustee or officer;
- c) Employee;
- d) Relative, spouse, domestic partner; or
- e) Provider of goods or services, material or other substantial interest that might inhibit objective decisions.

Furthermore, all matters discussed among reviewers within the context of reviewing and selecting proposals/applications, including evaluation scores, related discussion, and the review process, are CONFIDENTIAL and cannot be shared by reviewers with any individuals outside of the review activities through the duration of the open procurement period, unless First 5 Fresno County specifically authorizes such disclosure.
